- 6. Transfer/Euthanasia. In the event that you are unable to keep this animal, you agree to notify <Rescue Name> immediately by either mail or phone. You agree not to abandon, give away, sell, place in another home or dispose of the animal in any way without providing <Rescue Name> the opportunity to re-home the animal. You agree that you may not euthanize the animal except in the case of the animal's terminal illness or injury, or old age accompanied by pain and suffering. A licensed veterinarian must perform euthanasia and you will notify <Rescue Name> of the euthanasia.
- 7. **Lost Dog.** You agree to make a serious effort to find the animal if it becomes lost, by immediately (a) filing lost reports with the local police, animal control authorities, animal shelters, local veterinarians, and <Rescue Name> (b) posting lost dog signs and (c) putting an ad in the paper.
- 8. **Breach of Agreement/Liquidated Damages.** <Rescue Name>, reserves the right to follow through on this adoption in order to protect the welfare of the animal. In the event that you do not comply with the terms of this Agreement, or the animal is abused or neglected while in your care, one of our remedies will be to recover the animal from you upon demand. To this end, you will agree to allow visits to your home to assess the status of the animal and the conditions under which the animal is kept. After the demand, you will immediately surrender the animal to us. In addition, without waiving any of our rights under this Agreement, you will owe us a payment in the amount of \$250, agreed between us as just and reasonable liquidated damages to compensate us for our costs and expenses in connection with your breach of this agreement.
- No Liability. <Rescue Name> is not liable for any claims, legal actions, losses, injuries, damages, costs, expenses or liabilities whatsoever in connection with your adoption or ownership of the Dog.
- 10. Entire Agreement/Modification/Binding Effect. This Agreement is the entire agreement between you and us, and supersedes any prior understandings between you and us with respect to the subject matter of this Agreement. No modification of this Agreement will be valid unless in writing duly signed by both parties. This Agreement is binding upon your and our heirs, assigns, successors, personal representatives, and executors. This agreement between the parties is contained herein. You will notify <Rescue Name> if there is a change of address or telephone.
