I, my assignees, heirs, guardians, and legal representatives will indemnify, defend and hold harmless <Rescue Name> from and against any claims, lawsuits injuries, damages, losses, costs and/or expenses whatsoever sustained by me in connection with my volunteer activities for <Rescue Name>, or my breach of <Rescue Name> rules, regulations, policies and programs.
